- C. Minutes from 06/11/20; KD noted that the wrong "next meeting" date was documented. AU changed it in the record. It was moved, seconded, and unanimously approved that the amended minutes of the June meeting be accepted.

 - 1. Executive Committee Committee discussed conducting the annual performance review of the director; it was decided that the committee meet on 9/24/20 at 5PM.
 - 2. Board Development Committee- no report
 - 3. Finance Committee—The financial reports were reviewed and discussed. AM noted some changes from the last report were a result of how the money was moved around; earned revenue has dropped because it was moved to "direct contributions" toward Campaign for Kids. ReReads continues to do well.

Friends Upcoming fundraising events. 9/12: The Anti-Spelling Bee Bee, a 24 hour fundraising competition that asks teams to raise money and NOT spell, to replace the traditional Adult Spelling Bee during the pandemic; 10/19-10/24, APL Mystery Read Aloud, Beth Garcia's One Bloody Shirt at a Time, with community members reading the book throughout the week;

 - a. DW submitted and explained report; archived. Audit has started; curbside services still being offered but now patrons may use computers by appointment; considering reopening 7 weeks after school starts, around 10/7; Amazon revenue has topped \$10,000 overall, with 133 books sold online in July alone; library received a grant from the Texas Book Festival; looking into more CARES funding to become available; APL will participate in Permian Basin Gives, an online fundraiser for non-profits in

the area; Mary Beth's virtual children's programs are very successful with the community; Leaves to Leaves campaign: True Value will donate a tree to the library if patrons read a certain number of books; GoFundMe campaign to raise money for an outdoor theatre system so the library can safely offer a gathering of people outside to watch a movie or performance.
